It is **NOTIFIED** to all concerned that online applications are invited in the prescribed format for filling up 06 vacancies of Translator to be filled in by promotion from amongst the eligible staff (Judicial Assistants or Junior Judicial Assistants having experience of 3 years) of Rajasthan High Court under the provisions of Rajasthan High Court Staff Service Rules, 2002 (As amended), according to Pay Matrix Level Number L-11, in the Pay Scale of Rs. 37,800-1,19,700 as per Rules.

Notes:-

1. Minimum qualification shall be post graduate in English Literature from any recognized University established by Law in India. Preference shall be given to a Law Graduate.
2. A candidate shall have to secure minimum 55% marks in each paper and 60% marks in aggregate.
3. Both the papers will be taken in two shifts of two hours each on a single day.

Date & Place of Examination:-



Before conclusion of entire recruitment process, no information pertaining to this recruitment, shall be provided on the application submitted under Rajasthan Right to Information (High Court and Subordinate Courts) Rules, 2006, and the same could be provided as per rules, only after conclusion of recruitment process.
