Online Applications are invited from male & female eligible Indian Citizens for filling up following vacancies to the post of Assistant Commandant (Telecommunication) of Central Government Group-A, Gazetted Combatised Post (Non Ministerial) on temporary basis likely to be permanent in the Indo-Tibetan Border Police Force. On joining the organization, the candidates shall be governed by ITBPF Act, 1992 and ITBPF Rules, 1994 and other Rules applicable from time to time. The post has all India liability and selected candidates can be posted anywhere in India and even abroad. This is a combatised post and selected candidates shall have to wear the rank and badges of the post as per the orders/instructions issued by the Central Government from time to time. Applications from candidates will be accepted through ON-LINE MODE only. No other mode for submission of application is allowed. ONLINE APPLICATION MODE WILL REMAIN OPEN W.E.F. 21.01.2025 AT 00:01 AM TO 19.02.2025 AT 11:59 PM.

## 4. **ELIGIBILITY CONDITIONS:**

## a) Age Limit: Not Exceeding 30 years

## Educational Qualifications:-

#### Essential:

i. Bachelor's Degree in Telecommunication Engineering or Electronics and Communication or Electronics and Instrumentation or Engineering from a recognized University or Institution.

## b) Cut-off date for Age and Relaxations:

Crucial date for determining the age limit will be the closing date i.e. 19<sup>th</sup> February, 2025 (19/02/2025). Candidates should not have been born earlier than 20, February, 1995 (20/02/1995) and later than 19, February, 2007 (19/02/2007).

## Note:-

- i. The date of Birth as recorded in the Matriculation certificate available on the date of submission of application shall be accepted as proof for determining the age and no subsequent request for its change will be considered or granted.
- ii. The OBC Candidates must produce **OBC** (**NCL**) Certificate based on the income for the financial year 2023-24, 2022-23 and 2021-22 and issued on/after 01.04.2024 (after completion of financial year 2023-24) but not later than the closing date of the application for the examination.
- candidates who wish to be considered against reserved vacancies or seeking age relaxation must submit requisite certificate issued by the competent authority, in the prescribed format when such certificates are sought by the Recruitment Board. Otherwise, their claim for SC/ST/OBC(NCL) status will not be entertained and their candidature/applications will be considered under Unreserved (UR) category.

#### Explanation of Ex-Serviceman:-

An Ex-Serviceman means a person:

- (i) Who has served in any rank whether as a combatant or non-combatant in the Regular Army, Navy, Air Force of the Indian Union, and
- a) Who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his or her pension.

or

b) Who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension.

or

c) Who has been released from such service as a result of reduction in establishment.

or

(ii) Who has been released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity: and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service;

- i. The candidate must not have knock-knees, flat foot, varicose vein or squint in eyes and they should possess high colour vision. The candidates will be tested for colour vision by Ishahara's test as well as Edrich-Green Lantern test. An colour blind person will not be eligible for appointment. If at any stage of service career, a person is found to be colour blind, he/she will be boarded out as per SHAPE policy in vogue.
- ii. They must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of the duties.

## iii. Tattoos: -

- i) <u>Content</u>: Being a secular country, the religious sentiments of our countrymen are to be respected and thus, tattoos depicting religious symbol or figures and the name, as followed in Indian Army are to be permitted.
- ii) <u>Location</u>: Tattoos marked on traditional sites of the body like inner aspect of forearm but only left forearm, being non saluting limb or dorsum of the hands are to be allowed.
- iii) <u>Size</u>: Size must be less than ¼ of the particular part (Elbow or Hand) of the body.

### Note:-

In case, a candidate has undergone removal of tattoo (s) prior to appearing for recruitment process and the same has faded substantially, this will be treated as a "scar" and not a tattoo. Such candidates will be permitted to undergo the entire selection process with the approval of Presiding Officer of the recruitment Board. Further, the scar resulting due to removal of tattoo will be reviewed by the Medical Board of Officer during Detailed Medical Examination.

## 5. HOW TO APPLY AND BY WHICH DATE:

- a) Eligible and interested candidates need to apply online through ITBPF website <a href="https://recruitment.itbpolice.nic.in">https://recruitment.itbpolice.nic.in</a>. Candidates are advised to fill the online application form after reading the instructions carefully and should provide genuine and functional e-mail ID and Mobile number at the time of filling online application form. Details as required under various segments should be mentioned clearly, correctly and logically. As the applications need to be submitted online only, applications received offline shall not be considered and will be rejected summarily.
- b) Candidates are to fill all information e.g. Gender/Category (UR/SC/ST/OBC (NCL)/EWS etc), Employment status/Riots affected, etc. in the profile created on ITBP recruitment website before submission of online application. Any false/incorrect information in online application will lead to cancellation of candidature and no request for change in such details will be considered at later stages.
- c) APPLICATION FEE & MODE OF PAYMENT- Male candidates belonging to UR, OBC and EWS category applying for this recruitment will have to pay Rs. 400/-(Rupees Four hundred only) as application fee through the online payment gateway system on https://recruitment.itbpolice.nic.in. Application received with any other mode of fee payment will be summarily rejected. Candidates belonging to Scheduled Caste, Scheduled Tribe, Females and Ex-servicemen are exempted from paying the fee.

## Note:-

- i. Fee once paid will not be refunded under any circumstances.
- ii. Fee paid by modes other than online mode will not be accepted and the applications of such candidate will be rejected forthright. Besides above, the payment made in such cases shall stand forfeited.
- d) Candidates working in Central/State Government/ Autonomous/ Statutory Bodies/ Public Sector Undertaking etc. applied to the post are required to furnish "No Objection Certificate" in original as per Annexure-V issued by the employer at the time of verification of documents. The candidature of candidates who fail to submit "No Objection Certificate" at the time of documentation shall be summarily rejected.

 g) Candidates are strongly advised to apply well in time without waiting for the last date for submission of online application form.

## 6. <u>SELECTION PROCESS:</u>

- a. Admit Cards to the candidates will be issued online mentioning the date and venue of recruitment test. Candidature of candidates who are issued online admit cards will remain provisional till they are finally selected and submit all related documents/certificates in original and in prescribed format at the stage of verification of original documents.
- b. Candidates are required to bring a clear & legible print out of their online application form & admit card; else they will not be permitted to enter the venue of Physical Efficiency Test (PET) & Physical Standard Test (PST).

## Note:-

- i. Before start of PET/PST, the candidates will undergo thorough verification of identity including Biometric capture.
- ii. Biometric identification of candidates can also be verified at any stage of recruitment.
- iii. It is candidate's responsibility to check before hand that the biometric machines are able to capture the fingerprint image. In case, if the biometric machine is not able to capture the fingerprint image due to Mehndi, wax, etc. then, the candidate will not be allowed to appear in the examination.
- iv. Failure in biometric verification at any stage will lead to cancellation of candidature.

- ii) No marks will be awarded for this test and PET shall be qualifying in nature. Candidates have to qualify each event of PET, those who do not qualify shall be eliminated. There is no provision of appeal for Physical Efficiency Test (PET).
- (iii) On reporting of female candidates for Physical Efficiency Test (PET) & Physical Standard Test (PST), a self declaration indicating about her pregnancy status shall be submitted. In case, if she declares that she is not pregnant then, she may be allowed to participate in the PET/PST. In case of false declaration, all the risk for undergoing PET/PST will be of her own.
- (iv) If, the female candidate declares that she is pregnant before PET/PST, then a confirmatory pregnancy test to be done and in case she is found to be pregnant, irrespective of duration of pregnancy, she may be declared temporary unfit and her appointment shall be held in abeyance until the confinement is over. However, female candidate who are declared temporary unfit will require to appear and qualify in remaining stages of recruitment i.e. PST, Written Examination, Documentation and Medical Examination. The vacancy against which a women candidate was selected will be kept reserved for her. She will be re-examined for Physical Standard Test (PST)/Physical Efficiency Test (PET) six weeks after the date of confinement, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she is found fit, she may be appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instructions of the Government, as amended from time to time. In case, a female candidate is found negative for pregnancy, she may be allowed to participate in the PET/PST. However, it shall be mandatory for temporary unfit female candidate to appear and qualify PST, Written Examination, Documentation and Detailed Medical Examination/Review Medical Examination and has to secure place in final selection list of respective category.

### Note:-

PET will not be held for Ex-servicemen. However, they require to qualify the requisite PST, Written Examination, Documentation and Medical Examination.

## Physical Standard Test (PST)

(i) Candidates who qualify in PET will be screened for Height, Weight and Chest measurement (Chest measurement for male candidates only). Those who do not meet the required physical measurements, as applicable will be eliminated at that stage and rejection slip shall be issued by the Presiding Officer.

- (ii) Physical Standard of female candidates shall be measured by female staff only. Chest measurement of female candidates should not be taken. Besides, in case of female pregnant candidates shall be dealt as per instructions issued by the Central Government for PET/PST stage.
- (iii) Candidates who fail to qualify PST shall be eliminated from that stage and rejection slip shall be issued by the Presiding Officer.
- (iv) Rejection slip for less in height and chest will be issued at the time of PST. Board shall ensure that measurement is mentioned in writing in the rejection slip. In case, if candidate is not satisfied with the physical measurement recorded by the Board, he/she may make a representation/appeal in writing to the Presiding Officer of the Recruitment Board on the same day for re-measurement. In such case, the physical measurement of aggrieved candidate(s) shall be measured by the Presiding Officer himself and shall dispose off the representation/appeal immediately in writing to the candidate then and there. In case any candidate refuse to sign or leave the PST centre without signing the rejection slip, the recruitment board should endorse the remarks in the rejection slip as "candidate refused to sign/candidate left without receiving rejection slip/candidate did not turn up to receive rejection slip" and same may be kept in record properly after duly signed by the Presiding Officer of the board.
- (v) Underweight/overweight candidates will be allowed to participate for next stage of recruitment and shall not be debarred at PST stage. The final decision on fitness/unfitness due to underweight/overweight will be decided at the time of Detailed Medical Examination (DME) based on the weight and age on the day of DME and the height as measured by the PST Board.
- (vi) The decision of the Presiding Officer will be final and no further appeal or representation in this regard will be entertained thereafter. There is no provision of appeal for Physical Efficiency Test (PET).

- ii) No electronic gadgets including Mobile Phones or any accessories shall be allowed inside examination hall. However, scientific calculator may be allowed for technical part of written test. During the written examination only materials like clipboard, pen pencil, sharpener, eraser etc shall be allowed.
- iii) Candidates found copying or using any unfair means should be disqualified and debarred from further test. An endorsement also be made in all such confiscated answer sheets by the Board/Observer to this effect.
- iv) No representation for revaluation of answer sheet of written examination or re-conduct of written examination will be entertained.

- (i) Candidates will either be declared "FIT' or "UNFIT" in medical examination test and those who will be declared EXAMINATIO unfit will be allowed to undergo Review Medical Examination (RME), provided they give their written consent by appending their signature on the intimation, indicating the reasons for being unfit in the prescribed Annexure-'VII' given by the Presiding Officers/Chairman of the recruitment centre.
  - (ii) The consent for RME in the prescribed Annexure duly signed by the candidate will be submitted within 24 hours after he/she is informed for his/her unfitness in Detailed Medical Examination (DME).
  - (iii) Review Medical Examination (RME) of the candidate will be conducted in continuation of Detailed Medical Examination Test preferably on the next day.
  - (iv) The candidates who have been declared unfit in DME will be briefed about the procedure for filling an appeal for RME at the venue.
  - (v) There should be no provision of "Temporary Unfit" Medical Officers shall give their verdict as "FIT" or "UNFIT" in respect of each candidate.

- 14. Electrical and Electronic Measurements: Principles of measurement, accuracy, precision and standards; Bridges and potentiometers: moving coil, moving iron, dynamometer and induction types instruments, measurement of voltage, current, power, energy and power factor, instrument transformers, voltmeters and multi-meters, phase time and trequency measurement, Q-meters, oscilloscopes, potentiometric recorders, error analysis, Basics of sensors, Transducers, basics of data acquisition systems
- 15. Computer Fundamentals: Number systems, Boolean algebra, arithmetic functions, Basic Architecture, Central Processing Unit, 1/0 and Memory Organisation; peripheral devices. representation and programming, basics of Operating system and networking, virtual mernory. file systems; Elements programming languages, typical examples.
- 16. Systems and Signal Processing: Representation of continuous and discrete-time signals, shifting and scaling operations, linear,

time-invariant and causal systems, Fourier series representation of continuous periodic signals, sampling theorem, Fourier and Laplace transforms. Z transforms, Discrete Fourier transform, FFT, linear convolution, discrete cosine transform, FIR filter, IIR filter, bilinear transformation.

### 17. Power System:

Basic power generation concepts, steam, gas and water turbines, transmission line models performance, and cable performance. insulation, corona and radio interference, power factor correction. symmetrical components, fault analysis, principles of protection systems, basics of solid state relays and digital protection; Circuit breakers. Radial and ring-main distribution systems, Matrix representation of power systems, load flow analysis, voltage control and economic operation, System stability concepts, Wing curves and equal area criterion HVDC transmission and FACTS concepts, Concepts of power system dynamics, distributed generation, solar and wind power, smart grid concepts, environmental implications. fundamentals of power economics.

18. Power Electronics and Drives:

Semiconductor power diodes, transistors, thyristors, triacs, GTOs, MOSFETs and IGBTs-static characteristics and principles of operation, triggering circuits, phase control rectifiers, bridge converters – fully controlled and half controlled, principles of choppers and inverters, basis concepts of adjustable speed do and ac drives, DC-DC switched mode converters, DC-AC switched mode converters, resonant converters, high frequency inductors and transformers, power supplies.
